## **Indledning**

Første udgave af Den Lungemedicinske Litteraturkanon lå færdig i 2017. Den har siden været en hjælp for læger i hoveduddannelse til intern medicin: Lungesygdomme, til at kunne danne sig et overblik over litteraturen indenfor de forskellige områder i lungemedicinen. Hertil kommer de stadigt bredere dækkende faglige retningslinjer for lungemedicin, tilgængelige på:

I forbindelse med de obligatoriske specialespecifikke hoveduddannelseskurser er der tit et ønske fra kursisterne om at kunne orientere sig i kursets emner forud for selve afholdelsen af kurset. I denne 2. udgave er der lagt særlig vægt på, at artikler og retningslinjer i litteraturkanonen med fordel kan læses inden det specialespecifikke kursus begynder. Der er maksimalt 15 publikationer pr. emne og de 5 vigtigste er stjernemarkeret.

Da de specialespecifikke kurser gennem de sidste år er revideret, og visse emner er flyttet mellem kurserne, har det ligeledes været nødvendigt at 2. udgave af litteraturkanonen er omstruktureret svarende til de nye kursers indhold.

På vegne af Lungemedicinsk Selskab, håber vi, at den opdaterede litteraturkanon vil blive benyttet flittigt af både yngre læger under hoveduddannelse i lungemedicin, såvel som speciallæger der ønsker en opdatering på den nyeste litteratur indenfor et specifikt område.



## **Proces**




